1. Call to Order

Chair Halligan called the meeting to order at 3:00 p.m. noting that Kathy Narjes was absent and excused.

A. Nebraska Open Meetings Act

Chair Halligan stated that this meeting is subject to the Nebraska Open Meetings Act. A copy of the Act is posted in the meeting room.

B. Legal Notices

Chair Halligan acknowledged that the notice of this meeting was published in the area newspapers and the Affidavits/Proofs of Publication are included with these minutes.

2. Pledge of Allegiance

Chair Halligan led those in attendance in the United States Pledge of Allegiance.

3. Annual Director's Code of Conduct Review

Wittrock reviewed the Director's Code of Conduct which was added to the operating policies and was approved at the September 2023 board meeting pointing out a few items including being prepared for meetings and making a conscious effort to attend meetings. He encouraged the board members to review the Director's Code of Conduct.

4. Minutes

Wittrock reviewed various items listed in the accounts payable. 7. Director and Staff Reports

Kaiser, Davis, Keller, Reisdorff, Glanz, Sanders, and Hruska all submitted written reports.

8. *Ratify Fiscal Year 2023 Audit

Peetz reviewed the 2023 audit stating that the audit has been completed and has been sent to the state. The audit is a clean opinion. She then reviewed several items in the audit including total net position which was up 6.04% from last year and that revenues and expenses have both increased, but that expenditures were still under budget. The cash on hand is in a good position at over 7 months. The recommendation is for at least 3 months' cash on hand. Peetz then described charts Rauner & Associates provided which showed breakouts of general fund expenditures and revenue and net position and available cash. Discussion followed. Following discussion Maas moved to ratify the approval of the Fiscal Year 2023 Audit. A second was made by Johnson and with no further discussion a roll call vote was taken.

9. Preliminary Robust Review Update

Kuntz gave a preliminary Robust Review Update stating that NeDNR was not able to attend this meeting for the Robust Review and that their plan is to come for the February board meeting. Kuntz then

stated that there was an error found in the South Platte River Valley Subarea regarding original Municipal/Industrial robust review data in which the Big Springs Municipal modeling started at 2005 and should have started in 1997. He reviewed the updated results which showed a small accretion instead of a small depletion. Discussion followed.

10. Agency Reports

A. <u>USDA Natural Resources Conservation Service (NRCS)</u>

1. NRCS Report

Wittrock stated that Dickinson was not able to attend the meeting. Wittrock stated that Dickinson had reported that they were still working on CSP and EQIP. The Pheasants Forever Biologist position is vacant, and they will be interviewing for the position.

B. Nebraska Association of Resources Districts

1. NARD Report

Johnson stated that the next meeting is at the Legislative Conference January 22-24.

2. *NARD Legislative Session (60-Day Session)

Sprenger moved to authorize the SPNRD NARD delegates during the 2024 Legislative Conference to act upon the proposed legislation as deemed appropriate for the SPNRD. A second was made by Meyer and with no further discussion a roll call vote was taken.

11. General Reports

A. 2023 SPNRD Final Chemigation Program Report

Glanz reviewed the 2023 final Chemigation Program report stating that the District received 457 chemigation permit applications with 43 new permit applications and 413 renewal permit applications. There was also 1 emergency permit application. This is up from the 439 applications from 2022. In accordance with the District's rules and regulations, 50% of the renewal applications were inspected, totaling 177 systems. 21 failed and 7 of those have not come into compliance yet. They have until June 1, 2024, to do so. Glanz stated that overall, most systems were well maintained and managed. Several anti-pollution devices did need to be maintenanced. He then reviewed the chemical use stating that overall, 7,340,420 gallons of nitrogen fertilizer was applied over 47,386 acres resulting in 155 lbs. per acre. Glanz reviewed the financials which showed a net loss of \$2,456.71. This was mainly due to some unexpected maintenance.

B. <u>Summary of the 2023 Landowner/Operator Annual Nitrogen Management Reports</u>
Reisdorff reviewed the 2023 Landowner/Operator Annual Nitrogen Management Report stating that the Sidney Ground Water Quality Management Subarea is designated in Phase III and that there are

18,560 total acres and that approximately 3,179 irrigated acres were represented in the report. On average, the NRD nitrogen reporting form calculations recommended amount of fertilizer application was 22 lbs/acre of nitrogen. Producers with the subarea applied an average of 36 lbs/acre of nitrogen. The composite average for nitrate results was 11.35 ppm, which is down from 11.60 ppm last year. Reisdorff then reviewed the results based on each crop required to report in the subarea. He also reviewed historical results from 2011 to 2023. Discussion followed.

C. Summary of Nebraska Case Law for Nebraska NRDs

Wittrock reviewed the summary of Nebraska Case Law for Nebraska's NRDs focusing on several cases including cases on Board of Director Decision Review Ability regarding a variance request from a producer and the fact NRDs can require annual yield reports. Other cases that Wittrock reviewed were cases on Cease-and-Desist Orders and Erosion and Sediment Control. Discussion followed.

12. Committee Report

- A. Natural Resources Projects and Programs Committee, Meyer, Chair
 - 1. <u>Discussion Regarding Possible Changes to the SPNRD GWMA Rules and Regulations and Integrated Management Plan</u>

Meyer reviewed the possible changes to the SPNRD GWMA Rules and Regulations and Integrated Management Plan stating that the discussion regarding any changes to the allocations would be made after getting the robust review from the state.

2. <u>Process and Timeline Regarding Possible Changes to the SPNRD GWMA Rules & Regulations</u>

Wittrock reviewed the proposed timeline stating that the Projects and Programs committee will tentatively meet the next two months which will then be followed by the Countywide Ground Water Advisory Committee Meetings in late March to early April. Following them the hearing date is proposed to be Monday May 13 followed by the regular May board meeting on May 14. If the rules and regulations are set on May 14 they would go into effect on June 14, 2024.
