At the December 20, 2022, Board of Directors meeting, Chairman Bill Halligan recognized Phil Grabowski, Chris Meyer, Travis Glanz, and Tyler Sanders for their years of service.

Board of Director Meetings are hosted the second Tuesday of every month at the South Platte NRD office located at 551 Parkland Drive, Sidney, NE.





# **WATER QUALITY REPORT**

The following report summarizes the 2022 ground water quality monitoring program for the South Platte Natural Resources District (SPNRD). The SPNRD has completed its 34th year of monitoring nitrates in the District. Of the 167 network wells, 147 were sampled at least once in 2022. The District has four Ground Water Quality Management Subareas (GWQMSA) as shown on the map.

The composite averages for the past three years are shown in the table. Lodgepole Valley in Kimball County is not a subarea, however, several wells are included in our monitoring program. The Sidney GWQMSA is in Phase Three management control.



Producers in the Sidney Subarea are required to abide by the District's Nitrogen Reporting Program. During the January Board meeting, the Board directed staff to begin the process of transitioning the South Platte Valley from Phase One to Phase Two. Our Phases are as follows:

Phase I: nitrate-nitrogen levels of 6.5 ppm average for 3 consecutive years Phase II: nitrate-nitrogen levels of 8.0 ppm average for 3 consecutive years Phase III: nitrate-nitrogen levels of 9.5 ppm average for 3 consecutive years

## **CHEMIGATION PROGRAM REPORT**


The South Platte NRD received 439 chemigation permit applications during 2022. New permit applications totaled 35 with renewal permit applications totaling 404. Permits approved at any time during the calendar year expire on June 1st of the following year.

Renewal applications and fees must be received by June 1st.

All new Chemigation systems must be inspected prior to chemigating. Inspections check to see if the following Chemigation safety equipment is present and functioning properly.

- Mainline check valve with no leakage allowed. Located between irrigation pump & chemical injection point. (must be a certified check valve model)
- 2. Vacuum relief valve located between pump and check valve.
- 3. <u>Inspection Port</u> situated so inlet to low pressure drain can be observed. Must be 4" in diameter.
- 4. Low Pressure drain located behind check valve.
  - Orifice ¾" inside diameter minimum
  - · Must be flush with pipe inner surface
  - Must discharge in tube or pipe 20' from well site
- 5. <u>Chemical line check valve</u> located between injection point and chemical injection pump.
  - Minimum opening (cracking) pressure of 10 psi
  - \* A vacuum relief valve at the highest point of the chemical line can be substituted for the 10 psi requirement
  - Prevents flow from pipe into chemical tank
- 6. <u>Simultaneous interlock device</u> so irrigation pump and chemical injection pump are interlocked so that when irrigation pump stops the chemical injection pump stops.






## FY 2022 AUDIT AND BOARD ELECTIONS
